Please be advised that it is voluntary for you to supply to PCPD your personal data. All personal data submitted will only be used for purposes which are directly related to this application and the subsequent legal proceedings (if applicable). You have the right to request access to and correction of your personal data held by PCPD. Request for access or correction should be made in writing to the Data Protection Officer at the address shown in note 6. If considered appropriate, the personal data submitted may be disclosed to parties who will be contacted by PCPD during the handling of this case including your legal representative (if any), the prospective defendant (including, his legal representatives, if any), the courts or other parties concerned. The information provided may also be disclosed to agencies or organizations who are authorised to receive information relating to law enforcement, prosecution or challenge against the PCPD's decisions.

Information Notes

1) Who can apply for legal assistance?

Under section 66 of the Ordinance, if you suffer damage by reason of a contravention (a) of a requirement under the Ordinance; (b) by a data user; and (c) which relates, whether in whole or in part, to your personal data, you shall be entitled to compensation from that data user for that damage, and such damage may be or include injury to feelings. An application for legal assistance may be made to the PCPD pursuant to section 66B of the Ordinance.

2) How and when to apply?

After filling out this Form (LA001), the staff of PCPD may contact you for additional information through interview in person at the office of the PCPD or in such ways as considered appropriate by the PCPD.

You are required to provide the PCPD with your proof of identity (if you have not provided the same to PCPD before) for verification of your identity. In this regard, you may attend the PCPD to produce your identification document or send a copy of identification document to the PCPD for verification when making the application. If the applicant cannot be identified, the PCPD may not be able to process the application.

You normally have to lodge a complaint against the relevant data user with the PCPD first before applying for legal assistance. The PCPD will ascertain whether the nature of the act complained of falls within the ambit of the Ordinance, and if so, whether the complaint is substantiated based on the information gathered in the course of handling the complaint.

You should therefore provide all relevant information to the PCPD. If assistance is required, you may visit the office of the PCPD or telephone the PCPD. Your application may be refused if you fail or refuse to provide information or cooperate with the PCPD in connection with your application.

You should note that engaging in legal proceedings is time-consuming and would inevitably involve mental and physical strain. The pressure on the preparation of the evidence and the court procedures would be tremendous. Before you consider whether to apply for legal assistance to commence legal proceedings, you should also consider the chance that your action may not succeed and whether the defendant has sufficient assets to pay you if you do win the case. The outcome of the case (including compensation, if any) may not fully meet your expectation.

3) What information must be provided to the PCPD for making an application?

In order to enable the PCPD to process your application, you must provide details of the personal data concerned and the act or practice that is complained of, e.g. how and when was your personal data collected, processed, used, retained or handled. Please also explain the reasons why you consider your rights under the Ordinance have been infringed.

You must also state by whom the act was done or the practice was engaged in, i.e. the data user, and provide the details as prescribed in this Form. Please note that it is essential to specify and provide adequate information for identifying and locating the prospective defendant/ data user. Otherwise, the PCPD may not be able to process the application.

Please ensure all accompanying documents you consider relevant are sent together with your application.

4) What factors will be considered in deciding an application?

The PCPD may grant an application for legal assistance as it thinks fit to do so. For the factors that the PCPD will consider in exercising the discretion, please refer to Information Leaflet: "Legal assistance for civil claims under the Personal Data (Privacy) Ordinance".

5) How long does it take to process an application?

Normally, you will be informed of the result of the application in writing within 3 months after you have submitted all relevant information for the application. If a decision on your application cannot be made within three months, you will be kept informed of the position.
